# I. Rate Designations

# II. Applicability

Separately metered service for electric vehicle charger(s) with an aggregate nameplate capacity > 75 kW and  $\leq$  350 kW. Customers are prohibited from connecting any other loads to this service other than the vehicle charger(s). A Time-of-Use meter will be required to meter energy (kWh) and peak demand (kW) during the On-Peak and Off-Peak periods. The billing demand shall be the customer's greatest 15-minute demand in kilowatts (kW) incurred during the On-Peak period for which the bill is rendered.

# V. Special Terms and Provisions

- Customers who have their meter turned off and back on within a 12-month period will pay the minimum monthly charges, applicable to the customer, for the months while service was not being used.
- Customers are responsible for compliance with all applicable statutes and regulations governing the provision of
  electric vehicle charging, including, but not limited to, all taxing requirements, service rules and regulations
  established by CRMU, the State of Iowa, the Iowa Utilities Board, the Department of Revenue and any other
  jurisdictional entity.
- The customer will also be billed based upon a demand ratchet of 65% of the highest demand reading (kW) in the past 12 billing periods with the larger of the actual On-Peak (kW) reading or ratchet being billed. The billing demand shall be the customer's greatest 15-minute demand in kilowatts (kW) incurred during the month for which the bill is rendered.

# **Applicability Detail**

Available to any general service, commercial or industrial enterprise. A commercial enterprise is defined as a property classified as commercial or intended for commercial use and/or providing goods/services for resale to the general public. An industrial enterprise is defined as one making/creating (manufacturing) tangible goods for resale. Service under this rate schedule applies to multiple family dwellings (two or more units) served through one common meter or a single meter which provides service to at least one dwelling unit and building common areas such as hallway lights, laundry houses, service to separately metered residential-based structures where there is no dwelling unit (garages, barns, pumps, etc.).
