## Terms and Conditions

**Deadline:** Items must be purchased between January 1 and December 31 of the current year. Applications must be filed by January 31 of the following year. CRMU reserves the right to change any portion of this program or to end this program at any time without notice.

### Rebate Amounts & Payments:

Rebates will not exceed purchase price. Rebate applications will be processed as they are received on a first-come first-serve basis. Please allow 2 to 4 weeks for processing. The maximum annual residential rebate per dwelling is \$2,000.

**Qualifying Purchases/Eligibility:** New electric refrigerators, freezers, dishwashers, clothes washers, room or central A/C units, ground-source or air-to-air heat pumps, and water heaters are eligible for this program. The new appliances must meet all specified energy efficiency requirements. Compact Fluorescent Lamps eligible for this program include both integral ballast (one-piece unit) and adapter ballast (two-piece unit) models. CRMU does not endorse any particular manufacturer of appliances. Only CRMU residential electric or natural gas customers are eligible for these rebates.

**Verification:** Original or copied sales receipt(s) indicating purchase date, purchase location, quantity, and price must accompany rebate application. For more information, please review the terms and conditions on this form.

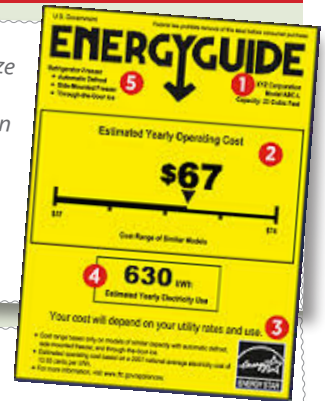
